- 4. The quantity of water for which this lien is filed is approximately 35 thousand cubic feet.
- 5. The amount due for water service is \$412.17.
- 6. Sewer service was furnished to the herein described property by the Claimant, at the rate provided by Title 3, Chapter 12 of the Code.
- 7. The amount due for sewer service is \$342.92.
- 8. The total amount due the Claimant is \$755.09.
- 9. The above amounts became delinquent on 6/18/2008.
- 10. Notice of the filing of this claim for lien was mailed to "owner or owners and party or parties interested in the premises" located at 3432 W.
