
TO HAVE AND TO HOLD the said real estate as described above, with the appurtenances, unto the Grantee, forever.

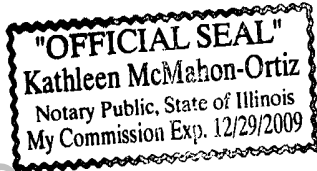
