THIS NINTH AMENDMENT (the "Amendment") to the Declaration of Condominium Ownership and of Easements, Restrictions Covenants and By-Laws for Princeton Club Towne Villas Condominium Association, recorded in the Office of the Recorder of Deeds of Cook County, Illinois on May 3, 1994, as document number 94-394980 (the "Declaration") is made and entered into this 25th day of June, 2008, by the Princeton Club Towne Villas Condominium Association, an Illinois not-for-profit corporation (the "Association").

WITNESSETH:

WHEREAS, upon recording of the Declaration the property legally described in Exhibit "B" hereto was submitted to the provisions of the timois Condominium Property Act; and

WHEREAS, pursuant to Article 14, Section 14.8 of the Declaration, the Declaration may be changed, modified or rescinded by an instrument in writing setting forth such change, modification or rescission, signed and acknowledged by the President or Vice President of the Board, and approved by the Unit Owners having, in the aggregate, at least sixty-seven percent (67%) of the total vote, at a meeting called for that purpose provided, however, that all holders of first mortgages of record have been notified by certified mail of any change, modification or rescission, and an affidavit by the Secretary of the Board certifying to such mailing is made part of such instrument, and such an affidavit is attached hereto as Exhibit "A"; and

WHEREAS, such amendment shall be effective upon the recording of such an instrument in the Office of the Recorder of Deeds of Cook County, Illinois.

NOW, THEREFORE, the Declaration is modified and amended as set forth hereinafter:

1. **ARTICLE 13:**

- A. Article 13, Section 13.1 (captioned "Unrestricted Transfers") is modified by the deletion of the word "lease" from the first sentence thereof.
- B. Article 13, Section 13.2 is deleted in its entirety, and replaced with the following:

3.2 Rental and Leasing Prohibited.

- (a) Application: Effective upon the date of recording of this Amendment (the "Effective Date"), and except as specifically set forth herein, the rental, lease, or other similar conveyance of the possession, use or occupancy of all or any part of a Unit to any person or entity shall be strictly prohibited.
 - (i) This pronibition shall apply to all Owners, and to all individuals (including an Owner's immediate family members) or entities acquiring a legal or equitable interest in a Unit after the Effective Date (including, but not limited to, an interest acquired by virtue of the death of an Owner).
 - (ii) Notwithstanding anything contained herein to the contrary, an Owner may allow immediate family members to possess, occupy or use a Unit.
 - (iii) For the purposes of this Amendment immediate family members" shall be defined as an Owner's spouse, grandparents, parents, siblings, children and grandchildren.
- (b) Orders of Possession: Notwithstanding the foregoing, the Board of Directors may rent or lease any Unit for which the Board or the Association is granted an order of possession in a forcible entry and detainer, foreclosure, or other legal or equitable proceeding. Any such lease or rental shall be in accord with applicable law, and on such terms and conditions as the Board of Directors deems reasonable and in the best interests of the Association.
- 2. ARTICLE 6: Article 6, Section 6.1 is modified, at the fifth sentence thereof, by the deletion of "April 1" and the insertion of "September 1" in its place.
- 3. Except as expressly set forth herein, all of the terms of the Declaration are hereby ratified and confirmed and shall remain in full force and effect.
