This is a Release (the "Release of Second Mortgage"), executed as of June 25, 2008 but not effective until release of this document from that certain escrow pursuant to an Escrow Agreement dated as of June 25, 2008 among the undersigned, Ambac Assurance Corporation and U.S. Bank National Association as Escrow Agent, of the Second Mortgage, Assignment of Rents and Security Agreement, dated as of June 1, 2003 (the "Second Mortgage") between MJH EDUCATION ASSISTANCE ILLINOIS I LLC, an Illinois limited liability company (the "Mortgage"), and AMBAC ASSURANCE CORPORATION (the "Mortgagee") and recorded with the Cook County Recorder of Deeds on July 3, 2003 as file number 0318431087.

### PRELIMINARY STATEMENT

- A. On June 25, 2008, the Illinois Finance Authority issued its \$47,165,000 Illinois Finance Authority Revenue Bon'ds, DePaul University, Series 2008 (the "Series 2008 Bonds").
- B. Proceeds of the Series 2008 Bonds will be used by the University in part to acquire title to certain educational facilities from the Mortgagor for a price sufficient to currently refund all outstanding Illinois Educational Facilities Authority Revenue Bonds, MJH Education Assistance Illinois I LLC, Series 1998C and 1998D (the "Series 1998C-D Bonds") and Illinois Educational Facilities Authority Revenue Bonds, MJH Education Assistance Illinois I LLC, Series 2003A and Series 2003B (the "Series 2003A-B Bonds"). The proceeds of the Series 1998C-D Bonds, together with the proceeds of the Series 1998A-B Bonds (as defined below), were lent to the Mortgagor to finance the acquisition, construction, renovation and equipping by Mortgagor of certain educational facilities for the benefit of DePaul University (the "University"). The proceeds of the Series 2003A-B Bonds were lent to the Mortgagor to refund the Illinois Educational Facilities Authority Revenue Bonds, MJH Education Assistance Illinois I, LLC, Series 1998A and 1998B (the "Series 1928A-B Bonds").
- B. In connection with the issuance of the Series 2003A-B Bonds, the following documents (among others) were executed:
  - (i) Amended and Restated Lease Agreement, dated as of June 1, 2003, between MJH Education Assistance Illinois I LLC and the University (the "Lease") and the properties listed on Schedules 1-13 attached hereto (collectively, the "Property");
  - (ii) Memorandum of Amended and Restated Lease Agreement dated as of June 26, 2003;
  - (iii) Loan Agreement, Mortgage and Security Agreement between MJH Education Assistance Illinois II LLC, as Mortgagor, and Illinois Educational Facilities Authority, as Mortgagee, dated as of June 1, 2003 (the "Mortgage");
  - (iv) The Second Mortgage:
  - (v) Trust Indenture, dated as of June 1, 2003, between Illinois Educational Facilities Authority and Bank One, National Association, as Trustee;

- D. Pursuant to Section 20.1 of the Lease, the University will have been deemed to have exercised its Purchase Option, as defined in the Lease, as to the Property.
- E. In connection with the University being deemed to have exercised its Purchase Option, the University requires this Release of Second Mortgage.
- F. Accordingly, the Mortgagor and the Mortgagee have executed this Release of Second Mortgage to be filed with the Office of the Recorder of Deeds of Cook County, Illinois pertaining to the parcels of real property described on Schedules 1-13 attached hereto.
