ORDER EXONERATING BOND

(b) As the defendant has been convicted, sentenced and has surrendered to the federal correctional institution to begin the custody portion of his sentence, the government submitted this motion to exonerate the bond. In addition, the government requested that this Court order the release of any lien or other encumbrance lodged against the real property and further order that the quit claim deeds executed in favor of the United States of America, currently held in the custody of the Clerk of the United States District Court, Northern District of Illinois, be returned to Kenard McCollum and to Demetrius of Collum at his property address.

Accordingly, it is horeby ORDERED, DIRECTED, and ADJUDGED:

- 1. That, as the defendent has been convicted, sentenced and has surrendered to the federal correctional institution to begin the custody portion of his sentence the security for the bond is no longer required, and the Court thus orders the bond exonerated. It is further ordered,
- 2. That, any liens or other encumbrances lodged against the real properties shall be released. It is further ordered,
- 3. - 4. That this Court shall retain jurisdiction of this matter to take such additional action and enter further orders as necessary to implement and enforce this order.
