This Fourth Amendment to Commercial Mortgage, Assignment of Rents, Security Agreement and Financing Statement ("Fourth Amendment") is dated as of August 10, 2008, and is made between Nasiruddin M. Daya, individually, whose address is 850 E. Northwes, Highway, Palatine, Illinois 60074 ("Mortgagor") and TCF National Bank, a national banking association ("Mortgagor"), with an office located at 800 Burr Ridge Parkway, Burr Ridge, Illinois 60527.

UNDERSTANDINGS

- 1. The Mortgagor executed a Mortgage in favor of the Mortgagee dated as of <u>January 6, 2006</u> and recorded <u>January 23, 2006</u>, as document number <u>0602304018</u> and First Amendment to Commercial Mortgage dated as of <u>January 29, 2007</u> and recorded on <u>February 26, 2007</u> as document number <u>0705702214</u> and Second Amendment to Commercial Mortgage dated as of <u>February 10, 2008</u> and recorded <u>March 23, 7008</u>, as document number <u>0808833175</u> and Third Amendment to Commercial Mortgage dated as of <u>May 10, 2008</u> and recorded on <u>June 18, 2008</u> as document number <u>0817022056</u> in the office of the County Recorder in and for <u>Cook County, Illinois</u> ("Mortgage") encumbering the real estate described on Exhibit A, attached hereto and made a part Sereof.
- 2. The Mortgage secures the indebtedness, obligations and liabilities of Mortgagor pursuant to an amended and restated commercial mortgage installment note dated <u>January 29, 2007</u> in the original principal amount of <u>One Million and 00/100</u> Dollars (\$1,000,000.00), due and payable on <u>February 10, 2012</u> ("Note A") and that certain promissory note dated <u>January 29, 2007</u> in the amount <u>Three Hundred Fifty Thousand and 00/100</u> Dollars (\$350,000.00), due and payable <u>February 10, 2008</u> and a First Note Modification Agreement dated <u>February 20, 2007</u> and a Second Note Modification Agreement dated <u>February 10, 2008</u> and a Third Note Modification Agreement dated <u>May 10, 2008</u> ("Note B"), payable to Mortgagee and executed jointly and severally by Mortgagor.
- 3. The principal balance of Note A is due and payable on <u>February 10, 2012</u>. As of the date hereof, the outstanding principal balance due is \$938,438.38. The principal balance of Note B is due and payable on <u>August 10, 2008</u>. As of the date hereof, the outstanding principal balance due is \$349,999.98.
- 4. Mortgagor wishes to amend the terms of Note B and the Mortgage, and Mortgagee is willing to do so.

- The Note B Maturity Date (as such term is defined in the Mortgage) shall be changed from August 10, 2008 A. to October 1, 2008. All references in the Mortgage to the phrase "August 10, 2008" are hereby deleted in their entirety and replaced with the phrase "October 1, 2008", and the phrase "Maturity Date" shall be amended to be defined as "October 1, 2008" ("Note B Maturity Date").
- In all other respects, unless specifically modified hereby, the Mortgage shall remain unchanged and in full force and effect.
