On January 25, 2008, Contractor continued contracting with Owner, Owner's tenant, or one knowingly permitted to contract for or on behalf of the Owner, for the construction of repairs, alterations and improvements to and for the oenefit of the Property, and under Contractor's contract with Owner, Contractor continued contracting with Subcontractor to perform the Work through which Subcontractor repaired, altered, improved and benefitted the Property
- 5. As of the last date of Work on August 31, 2008, Subcontractor has substantially completed all required by said contract to that date, and said Work has benefitted and improved the Property;
- 6. All the Work performed by Subcontractor for the benefit and improvement of the Property was done with the knowledge, consent and/or acceptance of the Owner who acquired title to the Property subject to known, unknown and/or inchoate lien rights of Subcontractor:

After credits for any prior payments, the total amount of one-hundred fifty one thousand seven hundred fifty six dollars and three cents (\$151,756.03) remains due and owing to Subcontractor for which sum, with interest, Subcontractor claims a lien on the Property, its improvements, and the monies or other considerations due or to become due from Owner under said contract between Contractor and Owner;
- 8. Notice has been duly given to Owner, and persons otherwise interested in the above described Property, as to the status of the undersigned as Subcontractor as provided by the Mechanics Lien Act, 770 LCS 60/5 and 60/24.
