

Parcel 1:

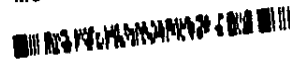
