IWe understand that the terms and conditions contained herein apply uniquely to the Public Right-of-Way and Easements of the property at the above a idress as legally described in Exhibit A and it is the intent of myself and the Village to have the terms and conditions of this instrument run with the land and be binding on subsequent purchasers.


