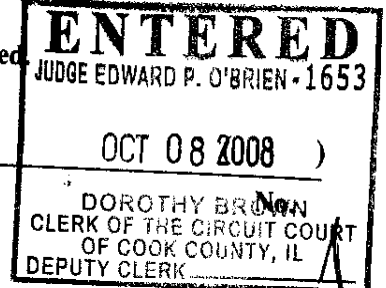
This matter coming on to be heard on the Court's own motion; the Court having been presented with a signed Release or
