

135 Custer is legally described as follows:





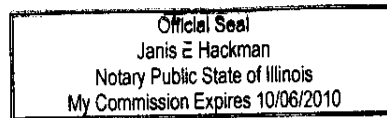
