This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws (hereafter the "Declaration") for 7612 N. Rogers Condominium Association (hereafter the "Association"), which Declaration was recorded on March 29, 2006 as Document Number 0608831077 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part hereof.

### WITNESS (4:

WHEREAS, the Board of Directors and Unit Owners desire to adopt an Amendment changing the percentage of the Unit Owners needed for a quorum as defined in the Declaration, paragraph 5.4(a), and

WHEREAS, pursuant to Paragraph 14.8 of the Declaration, the Declaration may be changed, modified or rescinded by an instrument in writing setting forth such change, modification or rescission, signed and acknowledged by the President or Vice-President of the Board, and approved by the Unit Owners, having, in the aggregate, at least sixty-seven percent (67%) of the total vote, at a meeting called for that purpose, provided, however, that all holders of first mortgages of record have been notified of by certified mail of any change, modification or rescission, and an affidavit by the Secretary of the Board certifying to such mailing is made a part of such instrument. Any amendment, change or modification shall conform to the provisions of the Act and shall be effective upon recordation thereof.

WHEREAS, said instrument has been signed and acknowledged by the President of the Board, and;

WHEREAS, an affidavit signed by the Secretary of the Board is attached hereto as Exhibit "B" certifying that such instrument has been approved, at a meeting called for such purpose, by

the Unit Owners having, in the aggregate, at least sixty-seven percent (67%) of the Unit Owners, as evidenced by the affidavit attached.

WHEREAS, an affidavit signed by the Secretary of the Board is attached hereto as Exhibit "C" certifying that a complete copy of the Amendment has been mailed to all first mortgagees having bona fide liens of record against any Unit, not less than ten (10) days prior to the date of such affidavit.

NOW, THEREFORE, the Association hereby declares that Paragraph 5.4(a) of the Declaration shall be amended as follows (additions in text are indicated in <u>underline</u> and deletions are indicated by <u>strike out</u>.)

- 5 Meetings
- (a) Quorum. Meetings of the Unit Owners shall be held at the Property or at such other place in the City as may be designated in any notice of a meeting. The presence in person or by proxy at any meeting of at least twenty fifty percent (20%) (50%) of the Unit Owners shall cont titute a quorum unless the Unit Owners, in accordance with the Act, provide otherwise. Unless otherwise expressly provided herein, any action may be taken at any meeting of the Unit Owners at which a quorum is present upon the affirmative vote of the Unit Owners having a majority of the total votes present at such meeting.

This amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except to the extent expressly set forth herein, the remaining provisions of the Declaration shall continue in effect without change.
