- 1. As of Mar in 1st, 2008 , the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$ 202,585.81 , consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest in a other amounts capitalized.
- Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 9.000 %, from March 1st, 2008 Borrower promises to make monthly payments of principal and interest of U.S. \$ 1,652.62 , beginning on the 1st cay of April , 2008 , and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. The yearly rate of 9.000 % will remain in effect until principal and interest are paid in full. By executing this Agreement, Borrower waives any Timely Payment Rewards rate reduction to which Borrower may have otherwise been entitled; and
- (b) all terms and provisions of any adjustable rate rider, or Timely Payment Rewards Rider, where applicable, or other instrument or document that is affixed to, wholly or partially incorporated into, or is part of, the Note or Security Instrument and that contains any such terms and provisions as those referred to in (a) above.
