WHEREAS, by a Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (the "Declaration") recorded in the Recorder's Office of Cook County, Illinois, on August 21, 2008 as Document No. 0823418029, by a First Amendment to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (the "First Amendment") recorded in the Recorder's Office of Cook County, Illinois, on September 5, 2008 as Document No. 0824918073, by a Second Amendment to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (the "Second Amendment") recorded in the Recorder's Office of Cook County, Illinois, on September 23, 2008 as Document No. 0826703070, and by a Third Amendment to the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (the "Third Amendment") recorded in the Recorder's Office of Cook County, Illinois, on October 16, 2008 as Document No. 0829045095, the Declarant submitted certain real estate to the provisions of the Illinois Condominium Property Act (the "Act"); and

WHEREAS, the Declaration reserves to the Declarant (as defined in the Declaration), and its successors and assigns, the right to annex and add to the Condominium Property (as defined in the Declaration) and thereby add to the Condominium created by the Declaration all or any portion of the Future Development Parcel (as defined in the Declaration); and

WHEREAS, the Declarant now desires to so annex and add to said Condominium Property and submit to the provisions of the Act and the Declaration certain real estate (the "Additional Property"), described in Exhibit A-4 attached hereto, which Additional Property is a portion of the Future Development Parcel (as defined in the Declaration);
