AMENDMENT TO MORTGAGE, ASSIGNMENT OF LEASES AND RENTS, SECURITY AGREEMENT AND FIXTURE FILING AND AMENDMENT TO ASSIGNMENT OF RENTS AND LEASES

THIS AMENDMENT TO MORTGAGE, ASSIGNMENT OF LEASES AND RENTS, SECURITY AGREEMENT AND FIXTURE FILING AND AMENDMENT TO ASSIGNMENT OF RENTS AND LEASES ("Amendment") is made as of November 3, 2008 by and between **UST PRIME III HOTEL OWNER, L.P.**, an Illinois limited liability company ("Mortgagor") and **CAPRI URBAN INVESTORS REIT**, a Maryland real estate investment trust ("Mortgagee").

- C. Pursuant to an Amendment to Loan Documents bearing even date herewith (the "Amendment to Loan Documents") Mortgagor and Mortgagee have agreed to amend the Original Loan Agreement and the other Loan Documents to extend the Maturity Date (the Original Loan Agreement, as amended by the Amendment to Loan Documents, is referred to herein as the Loan Agreement; and all capitalized terms used herein shall have the meaning set forth in the Loan Agreement unless otherwise defined herein).
- D. Mortgagor and Mortgagee have agreed to amend the Mortgage and the Assignment of Rents as provided herein, and the execution of this Amendment is a condition to the effectiveness of the Amendment to Loan Documents.
