THIS MODIFICATION OF MORTGAGE dated October 8, 2008, is made and executed between The Fell Company, a Corporation of Illinois, whose address is P.O. 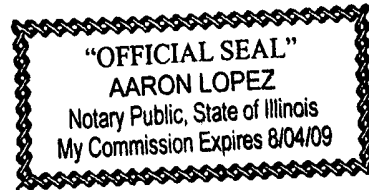
