- 4. That on or about March 6, 2008, at the special instances and the requests of the Owner, the undersigned claimant furnished extra and additional materials and additional labor on said premises with a value of five hundred fifty dollars (\$550.00). The following extra work was performed by the undersigned claimant: extra gravel & gravel, extra cleaning after masonry, etc.
- 5. That all of the labor and materials, including all extras, furnished and delivered by the undersigned claimant were delivered and used to permanently and substantially improve the above-described real property, and equally benefited all of the above Condominium Units on the premises.
- 6. That on or about March 6, 2008, the Owner breached the construction/renovation contract with the undersigned claimant by not allowing the claimant to complete and/or finish the remaining work under the contract.
- 7. That to date, Owner failed to compensate the undersigned claimant for the extra work that was performed on the Cyner's real property. Also, Owner failed to compensate the undersigned claimant for the erection of stairs.
- 8. That the materials and work furnished and delivered by the undersigned claimant equally benefited each and every Unit on 'a c above-described Lot/Tract of Land, and, therefore, shall be apportioned in equal shares between UNITS: 1N, 1S, 2N, 2S, 3N, 3S, 4N, 4S, 5N, 5S.

That there is now justly due and owed to the undersigned claimant after allowing all credits, deductions, payments and offsets, the outstanding amount of five thousand seven hundred fifty dollars (\$5,750.00), and, therefore, \$575.00 shall be allocated to each and every Condominium Unit on the premises, plus all lien recordation costs, filing fees and litigation costs, attorney fees and interest at the rate specified in the Illinois Mechanics Lien Act.
