The South 443 feet of the East 1/2 of the Northwest 1/4 of Section 17 (except the South 115 feet of the North 186 feet of the West 70 feet thereof and except the South 50 feet thereof taken for Joe Orr Road, and except that part thereof lying Southwesterly of the 100 foot right of way of Dixie Highway and except that part taken for Dixie Highway), also the South 443 feet of that part of the West 1/2 of the Northeast 1/4 of Section 17, lying West of the Westerly line of the 100 foot right of way of Riegel Road, now Chicago Road (except the South 50 feet thereof taken for Joe Orr Road), all in Township 35 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois; (excepting from the foregoing that part thereof falling within the following described tract:

That part of the East 1/2 of the Northwest 1/4 of Section 17, Township 35 North, Range 14, East of the Third Principal Meridian, described as follows:
