### SUBORDINATION AGREEMENT

This Agreement, niede and entered into as of this 12th day of November, 2008, by and between ALLEGIANCE COMMUNITY BANK ("Lender"), SOUTHWEST HOSPITALITY, LLC, an Illinois limited liability company, ("Mortgagor"), SOUTH HOSPITALITY, LLC, an Illinois limited liability company ('Borrower").

### RECITALS

WHEREAS, Lender has been requested to advance the sum of \$1,525,000.00 to Mortgagor and Lansing Hospitality, Inc., an Illinois corporation, and secure this new loan with a first mortgage and assignment of leases and rents upon the Property (the "2005 Mortgage").

WHEREAS, in order to induce Lender to make the loan in the amount of \$1.525,000.00 to be secured by the 2008 Mortgage, Borrower and Lender have agreed that lien interest in the Property arising from the Junior Mortgage shall be subordinated to the lien interest in the Property arising from the 2008 Mortgage.

WHEREFORE, in order to induce Lender to make the aforementioned loan secured by the 2008 Mortgage, Lender and Borrower hereby agree that Lender shall subordinate its interest upon the Property arising from the Junior Mortgage in favor of the interest of Lender arising from the 2008 Mortgage.
