applied to the unpaid principal balance of the Note dated December 29, 2006, as amended from time to time will be a rate of five percentage points over the Index (as defined in the Change In Terms Agreement dated November 17, 2008). The Index is currently is 4.5000% per annum. The rate of interest shall be adjusted as the Index rate changes, but under no circumstances will the rate on the loan be less than nine percent (9.000%) per annum. The outstanding principal balance under the Note as of the date of this agreement is \$2,073,189.83.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification hall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Nota". It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsure to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver arribes not only to any initial extension or modification, but also to all such subsequent actions.

CROSS-COLLATERALIZATION. In addition to the Note, this Mortgage secures the following described additional indebtedness: Promissory Note dated November 17, 2008, in the original principal amount of \$239,900,00 from Borrower to Lender, together with all renewals of, extension of, modifications of, refinancings of, consolidation of, and substitutions for the promissory note or agreements.
