SECOND MODIFICATION OF PRINCIPAL NOTE AND JUNIOR MORTGAGE

THIS SECOND MODIFICATION OF PRINCIPAL NOTE AND JUNIOR MORTGAGE ("Modification") is made and entered into this 4 day of _________, 2008, by JAMES D. ELVART ("Bearrower") and of THE POOBA TRUST ("Lender").

RECITALS:

- A. Lender has heretofore made a loan ("Loan") to Borrower in the original principal amount of \$100,000.00, evidenced by a Principal Note in said principal amount dated July 16, 2004 made by Borrower and payable to Lender, as mended by Modification of Principal Note and Junior Mortgage dated as of July 31, 2006 (as so modified, the "Note"). The Note is secured by a Junior Mortgage of even date with the Note, made by Borrower in favor of Lender, and recorded in the Office of the Cook County Recorder of Deeds on September 2, 2004 as Document No. 0424635027, as modified by the aforesaid Modification (as so modified, the "Mortgage"), encambering a condominium unit commonly known as Unit 1101 at the Five N. Wabash Condominium project in Chicago, Illinois and legally described on Exhibit A attached hereto (the "Condo Unit").
- B. Borrower is selling the Condo Unit to Lender and Borrower and his wife, Sarah C. Blue (collectively, "Mortgagors"), are acquiring certain property from Lender commonly known as 570 Winnetka Road, Winnetka, Illinois and legally described on **Exhibit B** auched hereto ("Winnetka Home").
- C. The parties desire to cause the lien of the Mortgage to be released from the Condo Unit and spread against the Winnetka Home, subject and subordinate to first mortgage financing, and to modify and amend the Note and the Mortgage (collectively, the "Loan Documents") as provided here in.
- NOW, THEREFORE, in consideration of the foregoing recitals, the mutual coverages and agreements contained herein, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:
- 1. <u>Incorporation of Recitals</u>. The aforesaid Recitals are hereby incorporated into this Modification as if fully set forth in this Paragraph 1.
- 2. <u>Amendment to Loan Documents</u>. The lien of the Mortgage is hereby released from the Condo Unit. Mortgagors hereby mortgage, grant, assign, remise, release, warrant and convey and grant to Lender a mortgage lien on the Winnetka Home, subject and subordinate to any first mortgage financing of Mortgagors, or any replacement first mortgage financing. From and after the date hereof, all references in the Loan Documents to the Property or Premises shall be deemed to refer to the Winnetka Home; and (ii) the Note shall be secured by the Mortgage as modified by this Modification.
- 3. <u>Full Force and Effect; Inconsistency</u>. Except as herein modified, the terms, conditions and covenants of the Loan Documents shall remain unchanged and otherwise in full force and effect. In the
