After Defendant Allen Thrasher was served with process on 8-28-00, a judgment was entered against him on January 4, 2002 for \$50,000 which was subsequently satisfied by Sheriff's Sale levy execution No. 055243-001L on January 31, 2006 which had its Certificate of Sale recorded as Document No. 0604010125 which then merged into the Sheriff's Deed issued on December 13, 2006 to AXXA, Inc. and recorded as Document No. 0635331081.




