SEVENTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS FOR 30 W. OAK CONDOMINIUM

THIS SEVENTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS FOR 30 W. OAK CONDOMINIUM ("Seventh Amendment") is made as of this 16 day of 00, 2008, by the Board of Directors of the 30 W. Oak Condominium Association (the "Board"):

WITNESSETH

WHEREAS, the Board administers certain real estate, hereinafter described, located in Chicago, Cook County, Illinois; and,

WHEREAS, the Total Parcel (as defined by the Declaration described below) which includes, but is not limited to said real estate together with all buildings, structures, improvements and other permanent fixtures of whatsoever kind thereon, and all rights and privileges belonging or in any vise pertaining thereto, have been submitted to the provisions of the Illinois Condominium Property Act (the "Act"); and,

WHEREAS, the Total Parcel hereby submitted to the provisions of the Act is legally described as in Exhibit A to the Declaration; and,

WHEREAS, the Total Parcel is subject to that certain Declaration of Condominium Ownership for 30 W. Oak Condominium recorded with the Recorder of Cook County, Illinois on October 18, 2006 as document number 0629110006, as amended by First Amendment recorded on December 1, 2006 as document number 0633517012, by Second Amendment recorded on December 28, 2006 as document number 0635215110, by Third Amendment recorded on December 29, 2006 as document number 0636109036, by Fourth Amendment recorded on December 29, 2006 as document number 0636309031, by Fifth Amendment recorded on May 3, 2007 as document number 0712315043, by Sixth-Special Amendment recorded on December 21, 2007 as document number 0735515069; and by Sixth Amendment recorded on June 25, 2008 as document number 0817731068 (collectively, the "Declaration"); and,

WHEREAS, Article XVII, Section 17.8 of the Declaration provides a procedure for amending the Declaration upon approval by Unit Owners having at least seventy-five percent (75%) of the total votes at a meeting called for the purpose of passing such an amendment; and,

WHEREAS, Article VI of the By-Laws provides a procedure for amending the By-Laws upon approval by Unit Owners having at least sixty-seven percent (67%) of the total votes at a meeting called for the purpose of such an amendment; and,

WHEREAS, the amended portions of the Declaration contained in this Seventh Amendment have been approved by a vote of Unit Owners having at least seventy-five percent (75%) of the total vote at a special meeting of owners held on _______, 2008; and,

WHEREAS, the amended portions of the By-Laws contained in this Seventh Amendment have been approved by a vote of Unit Owners having at least sixty-seven percent (67%) of the total vote at a special meeting of owners held on ______, 2008; and,

NOW, THEREFORE, in furtherance of the foregoing Recitals, the Declaration and By-Laws are hereby amended in accordance with the following:

1. Article IX, Section 9.2 of the Declaration is amended by deleting the second to last sentence beginning with "The" and ending with "months" in its entirety, and replacing it with the following:

"The leasing or sale of Parking Units may only be made to another Unit Owner or resident, and any such leases may be for terms of less than six (6) months."

2. Article II, Section 2.3 of the By-Laws is amended by deleting the fourth sentence beginning with "Thereafter" an 1 ending with "meeting." and replacing it with the following:

"Thereafter, there shall be an arrival meeting of the Unit Owners on the first Monday of December of each succeeding year at 7.00 p.m., or at such other reasonable time or date as may be designated by written notice of the Board delivered to the Unit Owners not less than ten (10) days or more than thirty (30) days prior to the date fixed for said meeting."

3. Article III, Section 3.1 of the By-Laws is amended by adding the following immediately after the fifth sentence ending in "each.":

"At the annual meeting in December, 2008, the four (4) candidates receiving the highest number of votes shall be elected to a term of two (2) years each, with the three (3) candidates receiving the next highest number of votes being elected to a term of one (1) year each. Thereafter, at each following annual meeting, expired director positions shall be elected to two (2) year terms."

In addition, the last sentence of Section 3.1 is amended by striking the words "one-half (1/2)" and replacing them with "one-third (1/3)".

- 4. Article V, Section 5.1 of the By-Laws is amended by striking the words "August 1st" in the first sentence and replacing them with "November 1st", and striking the words "August 15th" in the sixth sentence and replacing them with "November 15th".
- 5. All remaining provisions of the Declaration and By-Laws shall remain in full force and effect.
