The attorney named herein shall not be obligated to furnish bond or other security.



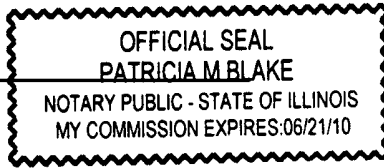
