That on April 18th, 2007, and subsequently, Owner owned fee simple title to the Real Estate (including all land and improvements thereon) (as used herein, the "Real Estate which commonly known **2000-2006 West Warren, Chicago, Illinois** and legally described as follows:

Lots 1, 2 and 3 in Scott and Gage's Subdivision, a Re-subdivision in Section 7, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

On, April 18th, 2007 **Deeke Construction** was the Owner's contractor for improvement on the Real Estate.

That on April 18th, 2007, Claimant made a contract (the "Subcontract") with the contractor under which Claimant agreed to provide materials for a project on the Real Estate for the total amount of **\$111,849.55** Contractor was authorized to enter into the Subcontract for the improvement of the Real Estate.

Claimant last performed work and/or provided materials under the Subcontract on **October 1, 2008**

As of the date of this Lien, there is due, unpaid and owing to Claimant, after allowing all credits, the principal sum of **\$3,172.35**, which principal amount bears interest at the statutory rate of 10% per annum. As result, Claimant claims a lien in this amount, plus statutory interest against said Contractor and the Owner on the Real Estates (including all land and improvements thereon) and on the money or other consideration due or to become due from the Owner under the Owner's contract with the Contractor.

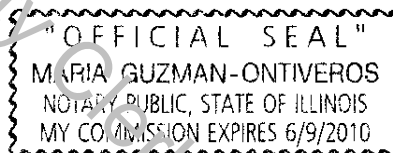
