### ADDENDUM TO RECIPROCAL EASEMENT AND OPERATING AGREEMENT

THIS ADDENDUM TO RECIPROCAL EASEMENT AND OPERATING AGREEMENT (this "Addendum") is made and entered into as of the 3/7 day of December, 2008 by 108 N. STATE RETAIL LLC, an Illinois limited liability company ("Retail Owner") and CHICAGO TRANSIT AUTHORITY, a municipal corporation of the State of Illinois ("CTA").

### RECITALS:

- B. Pursuant to the CTA Development Agreement, the Subsequent Closing (as defined in the CTA Development Agreement) has occurred and 108 Transit has conveyed to CTA title to the Below Grade Parcel as legally described on **Exhibit A** attached hereto and the rest of the Below Grade Property in accordance with the CTA Development Agreement.
- C. Retail Owner is the owner of the Retail Property, including without limitation, the Retail Parcel as legally described on **Exhibit B** attached hereto.
- D. Upon the conveyance of the Below Grade Property to CTA (and so long as CTA owns the Below Grade Property), CTA will be Below Grade Owner under the REA.
- E. Pursuant to Section 5 of the Second Amendment to the CTA Development Agreement, this Addendum is being entered into in order to memorialize the grant of the construction access easements by the Retail Owner in favor of CTA and its successors, grantees and assignees, and their respective Construction Designees.
- F. This Addendum is being entered into by Retail Owner and CTA (22 Below Grade Owner) pursuant to Section 2.1.4 of the REA.
- G. The terms used in this Addendum, if not otherwise defined in this Addendum, shall have the meanings set forth in the Agreement.
- **NOW, THEREFORE**, in consideration of the foregoing Recitals and the covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retail Owner and CTA hereby agree as follows:
- 1. <u>Construction Access Easements</u>. As between the Retail Owner and CTA (and the successors, assigns and grantees of CTA), the following easements (the "*CTA Access Construction Easements*") are hereby granted by Retail Owner to CTA (and the successors, assigns and grantees of CTA) in accordance with Section 5 of the Second Amendment to the

CTA Development Agreement and shall replace the easement of ingress and egress granted by Retail Owner to Below Grade Owner under Section 6.1.1 of the REA:

### 6.1.1 <u>Ingress and Egress</u>.

Retail Owner hereby grants, for the benefit of CTA, its successors and (i) assigns, and their respective Construction Designees (collectively, "CTA Permitted Parties"), easements for ingress, egress and access to enable the CTA Permitted Parties to perform work on the Below Grade Project subject to the provisions herein set forth. Attached hereto as **Exhibit C** are drawings delineating the ground floor and lower levels of the Retail Project and designating thereon the general location of non-exclusive areas, sidewalks, ramps, pathways and corridors ("CTA Construction Access Easement Areas') that shall be made available by Retail Owner for use by CTA Permitted Parties from time to time in connection with and during the construction of the Below Grade Project by CTA or its successors, grantees and assigns. The use of the CTA Construction Access Easement Areas shall be subject at all times to the following provisions: (a) no portion of the CTA Construction Access Easement Areas shall be used by the CTA Permitted Parties for storage or staging of materials or equipment, but may be used only to transport and carry vorters, materials and equipment for use in connection with construction of the Airport Check-In Facility and the Station Facility; (b) any access to and use of the CTA Construction Access Easement Areas shall give due regard for the use of the CTA Construction Access Easement Areas by Retail Owner and its Permittees (and their respective Construction Designees) in the construction, operation, use, and maintenance of the Retail Project; (c) no materials and equipment which are not appropriate for the size and location of the CTA Construction Easement Areas (including, without limitation, rail, rail cars or similar large infrastructure materials or equipment) or which would likely cause damage to surrounting improvements shall be carried or transported through the CTA Construction Easemen Areas; (d) all construction activities using the CTA Construction Easement Areas, or in, co or about the CTA Construction Easement Areas, shall be properly permitted by all appropriate governmental agencies including compliance with local fire and life-safety codes and applicable Laws; (e) any damage to the CTA Construction Easement Areas and any portion of the Retail Project shall be promptly repaired and restored to the same condition as existed prior to said damage or casualty at no cost to 108 Transit and Retail Owner or any of their Permittees or Occupants, or the operator of any Parking Garage or any other belov/ grade parking areas; (f) all insurance required by third-party contractors under Section 12.02(b) and Section 12.02(d) of the CTA Development Agreement or otherwise required under the REA shall be in full force and effect; (g) use of the CTA Construction Easement Areas shall not unreasonably disrupt or interfere with the normal operations of the Retail Project or the use of the Retail Parcel Improvements including, but not limited to, retail uses and traffic in the Pedway, below grade parking areas and other mechanical equipment serving the Retail Project, it being understood that (i) Retail Owner shall have no obligation to make any physical modifications or alterations to any of the Retail Project to accommodate the CTA Construction Easement Areas, (ii) although Retail Owner shall be obligated to cooperate in good faith with CTA to allow reasonable access to and use of the CTA Construction Easement Areas for the purposes set forth herein, Retail Owner and CTA agree that the CTA Construction Easement Areas depicted on

Exhibit C are only illustrative of the possible routes for access of men, materials and equipment and Retail Owner shall (A) have the right to modify the location of the CTA Construction Easement Areas located in the Retail Project, from time to time, and (B) retain the right to temporarily halt or redirect or relocate construction traffic of men, materials and equipment in any of the CTA Construction Easement Areas located in the Retail Project to other areas on the levels of the Retail Project to avoid material interference with the operations of the Retail Project so long as reasonable alternate access is provided to CTA and the CTA Permitted Parties to enable CTA and the CTA Permitted Parties to expeditiously and continuously perform work on the Below Grade Project as provided herein, and (iii) Retail Owner and 108 Transit have the right to be reinbursed by CTA for any actual losses, costs, claims or damages incurred by 108 Transit and Retail Owner in connection with the use of the CTA Construction Easement Areas by CTA and its successors, grantees and assigns, or any of the CTA Permitted Parties and the management and coordination of the use of the CTA Construction Easement Areas, including reimbursement for reasonable additional necessary labor and personnel and for lost parking revenue because of the inability of any parking operator to park cars in any portion of the Parking Garage because of the use of the CTA Construction Easement Areas by CTA and its successors, grantees and assigns, or any CTA Permitted Parties, but excluding any incidental or consequential damages; and (h) use of the CTA Construction Easement Areas shall be subject to such reasonable rules and regulations established and consistently and uniformly applied by Retail Owner to govern the entrance, access and exit by men and materials by the CTA Permitted Parties to the Retail Project.

- (ii) Notwithstanding the provisions of Section 6.1.1(i) above, Retail Owner and CTA agree and acknowledge that use by CTA of the shafts extending vertically from the locations at the street levels of State and Dearborn as depicted on the attached Exhibit C and the adjacent street lanes and sidewalk, may be required in connection with resumption and completion of construction of the Below Grade Project, including the use of the locations at the street levels of State and Dearborn for temporary storage and staging of materials and equipment. CTA and Retail Owner will jointly use best efforts to develop a logistics plan for use of the vent shafts, street lanes and sidewalks, including any use for temporary storage and staging, that will minimize disruption to the operation of the Retail Project and construction of the Below Grade Project, in being understood and agreed that the location of the ventilation shafts on Exhibit C shall not dictate or be conclusive as to provisions of the jointly approved logistics plan as provided nerein and that the logistic plan shall neither deny CTA access to, nor require the relocation of, the shafts.
- (iii) Upon the substantial completion of the Below Grade Project by CTA (or its successors, assigns or grantees) and the commencement of operation of the Rail Service as defined in, and in accordance with, the CTA Development Agreement, the CTA Construction Easements as granted in this Addendum shall no longer apply and the easements of ingress and egress as contained in Section 6.1.1 of the REA shall be reinstated with respect to any subsequent work on the Below Grade Parcel or to the Below Grade Project.

- (iv) So long as CTA owns the Below Grade Project, with respect to any construction by CTA or its successors, assigns or grantees on the CTA Parcel, the indemnity and insurance provisions set forth in the CTA Development Agreement shall replace the indemnity and insurance provisions set forth in Section 6.3 of the REA. Upon the transfer by CTA of the Below Grade Project, the indemnity and insurance provisions set forth in Section 6.3 of the REA shall be reinstated and shall apply to any construction undertaken by the Below Grade Owner on the Below Grade Project.
- 2. Address for Notices to CTA. From and after the date hereof, the address for notices to the Below Grade Owner set forth in Section 21.1 of the REA shall be deleted and replaced with the following:

3. <u>Amendment/Force and Effect</u>. Except as set forth in this Addendum, the terms and agreements set forth in the REA shall be and remain unmodified and in full force and effect. This Addendum shall be binding upon and inure to the benefit of Retail Owner and CTA and their respective successors, grantees and assigns. In the event of a conflict or inconsistency between the provisions of the REA and the provisions of this Addendum, the provisions of this Addendum shall govern and control.




