Harris Smith ("Guarantor") in favor of Mortgagee; and any and all other instruments and documents executed by or on behalf of Mortgagor and delivered to Mortgagee in connection with the Loan, which are hereinafter collectively referred to as the "Other Security Documents": and

WHEREAS, on or about October 31, 2008, Mortgagor conveyed the Property (as defined in the Mortgage) to Sono West LLC, an Illinois limited liability company and Fremont Commercial LLC, an Illinois limited liability company;
