On or about August 2, 2006, Forming Concepts entered into a subcontract with Millennium Concrete Construction, LLC ("Subcontractor"), under which Forming Concepts agreed to provide, among other things, formwork for the construction of a high rise building at 110 W. Superior ("Project"). Evans Construction Services, LLC ("Prime Contractor") signed the credit application on behalf of Subcontractor.

3. The Subcontract was entered into by Subcontractor and the work was performed by Forming Concepts with the knowledge and consent of Prime Contractor and Owner. Alternatively, Owner and Prime Contractor authorized or knowingly permitted Subcontractor to enter into contracts to improve the Real Estate. Alternatively, Owner and Prime Contractor knowingly permitted Subcontractor or Forming Concepts or both to perform Work to improve the Real Estate.

4. Forming Concept's materials are still on site.

5. As of the date hereof, after allowing all credits, there is due, unpaid and owing to Forming Concepts, the principal sum of Forty Two Thousand Seven Hundred Twenty Nine Dollars and 19/100 (\$42,729.19) for which, with interest, Forming Concepts claims a lien against the Real Estate.

6. Forming Concepts hereby revokes any waiver of lien given in advance of payment for which payment was not made.

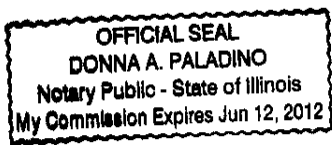
