SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR SONO WEST CONDOMINIUM

This Second Amendment to Declaration of Condominium Ownership for SoNo West Condominium ("Second Amendment") is made this 134 day of January, 2009 by SONO WEST LLC, an Illinois limited liability company ("Declarant").

RECITALS:

- A. Declarant has heretofore recorded that certain Declaration of Condominium Ownership for SoNo West Condominium with the Recorder of Cook County, Illinois on November 8, 2008 as document number 0831145010, as amended by First Amendment recorded with the Recorder of Cook County, Illinois on December 16, 2008 as document number 083.7122030 (as so amended, the "**Declaration**"), whereby Declarant submitted to the provisions of the Illinois Condominium Property Act ("Act") the Condominium Parcel (as defined in the Declaration).
- B. The Declaration reserved to Declarant the right to annex and add to the Condominium Parcel, and the edy add to the condominium created by the Declaration, all or any portion of the Add-On Parcel (as defined in the Declaration) for the purpose of constructing additional Units.
- C. Declarant now desires to so ar nex and add to the Condominium Parcel and submit to the provisions of the Act and the Original Declaration certain portions of the Add-On Property as described in <u>Second Amended Exhibit B-1</u> attached hereto and incorporated herein by this reference as Levels 7-12 and 14 (said portions being, the "Second Add-On Parcel").
- **NOW, THEREFORE**, Declarant does hereby amend the Original Declaration (the Original Declaration as amended hereby being, the "**Declaration**"), as follows:
- 1. <u>Recitals</u>. The foregoing recitals are incorporated in this Second Amendment as though fully contained herein.
- 2. <u>Additional Property</u>. The Second Add-On Parcel is hereby annexed to the Condominium Parcel, and is hereby submitted to the provisions of the Act as part of Condominium in accordance with, and shall be deemed governed by, the terms and provisions of the Declaration. Accordingly, from and after the date hereof all references in the Declaration to the Condominium Parcel shall include the Second Add-On Parcel.
 - 3. <u>Amendments</u>. The Original Declaration is further amended as follows:
 - A. Legal Description of Condominium Parcel. <u>Exhibit B-1</u> of the Original Declaration (Legal Description of the Condominium Parcel) is hereby amended by deleting said <u>Exhibit B-1</u> and substituting <u>Second Amended Exhibit B-1</u> attached hereto in lieu thereof.

- B. Additional Condominium Area. Exhibit B-2 of the Original Declaration (Additional Condominium Area) is hereby amended by deleting said Exhibit B-2 attached hereto in lieu thereof.
- C. Plat of Survey. Exhibit C of the Original Declaration (Plat of Survey) is hereby amended by replacing page 2 of said Plat of Survey with pages 2 and 2A attached hereto and made a part hereof by adding to the Plat of Survey pages 16, 17 and 18, which additional pages are attached hereto and incorporated herein by this reference. Exhibit C will hereafter consist of the original Exhibit C with replacement pages 2 and 2A and the additional pages 16, 17 and 18 attached hereto.
- D. Forcentage of Interest. Exhibit D of the Original Declaration (Percentage of Interest in the Common Elements) is hereby amended by deleting said Exhibit D and substituting Second Amended Exhibit D attached hereto in lieu thereof. The percentage of ownership in the common elements appurtenant to each Unit is hereby amended to be the percentages set forth in Second Amended Exhibit D attached hereto.
- E. Number of Units. The Chaximum number of Units to be submitted as part of the Condominium Property is a vo hundred (200), including the Parking Unit. Ten (10) Units were submitted with the Original Declaration, twenty-four (24) Units were submitted with the aforesaid First Amendment, and nine (9) Units are being submitted with this Second Amendment as the Second Add-On Parcel, and an additional one hundred fifty-seven (157) Units, including the Parking Unit, remain to be submitted as part of the remaining Add-On Parcel.
- F. Temprary Construction Easement. Declarant hereby grants and conveys to the East Parcel Owner a temporary construction easement, apportenant to the East Parcel, over and above the Condominium Property, but in no event shall such temporary construction easement include access to the roof of the Condominium Property, for the operation of a tower crane, or similar equipment in connection with construction of improvements on the East Parcel. Such temporary construction easement is intended to benefit the East Parcel Owner as will as the contractors or subcontractors constructing such improvements on the East Parcel. Declarant shall not obstruct or interfere in any way (nor permit or allow any lessee, occupant or any person or entity under the control of Declarant to do so) with the foregoing temporary construction easement and rights granted hereunder. Said temporary construction easement shall terminate upon completion of such improvements on the East Parcel,, and shall be subject to all other provisions of the Declaration applicable to Easements.
- 4. <u>Common Elements</u>. The additional Common Elements annexed to the Condominium by this instrument are hereby granted and conveyed to the grantees of all

Units, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.

5. <u>Inconsistencies</u>. Except as expressly set forth herein, the Original Declaration shall remain in full force and effect in accordance with its terms. Any inconsistencies between the Original Declaration and this Second Amendment shall be resolved in favor of the provisions contained in this Second Amendment.




