### LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of October 26, 1999, but made effective as of September 1, 1999, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"), MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED June 21, 1996 A/K/A TRUST NO. 2060 ("MORTGAGOR") & FELIX GOMEZ and MIGUELINA GOMEZ, HIS WIFE, ("BORROWERS").

### WHEREAS:

- The BORROWER has heretofore executed a Promissory Note dated August 19, 1996 in the principal 1. amount of \$75,000.00 of which the BANK is presently the holder;
- The NOTE is secured by a Mortgage, Assignment of Korts & Security Agreement (Chattel Mortgage) 2. dated August 19, 1996 and recorded in the Recorder's Office of Cook County, Illinois, as document number 96-644867 ("MORTGAGE"), conveying to BANK certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land 3. Trust which is known as Mid Town Bank and Trust Company of Chicago attu Trust Agreement dated June 21, 1996 a/k/a Trust No. 2060 ("ASSIGNMENT OF BENEFICIAL INTEREST") which land trust holds title to the described REAL ESTATE:
- The NOTE is further secured by Personal Guaranty(s) ("GUARANTY(S)") dated of even date therewith 4. and executed by the GUARANTORS guaranteeing repayment of the indebtedness evidenced by said NOTE:
- 5. The BANK has disbursed to BORROWER the sum of \$75,000.00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE;
- 6. The interest rate evidenced on said NOTE is 8.25% per annum:
- 7. The maturity date evidenced on said NOTE is September 1, 1999;
- 8. The BORROWER desires to amend the loan amount and maturity date as evidenced by the NOTE;

9. The BANK has agreed to take modification pursuant the terms and conditions of a commitment of the BANK dated October 26, 1999 ("COMMITMENT").

**NOW THEREFORE**, notwithstanding anything contained to the contrary in the NOTE, MORTGAGE, AND GUARANTY(S), and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of this date is \$58,550.99.
- B. The maturity date is hereby amended to **September 1, 2006**.
- C. Except as modified herein, the terms, covenants and conditions of the MORTGAGE shall remain unchanged and otherwise in full force and effect. In the even of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE, the terms herein shall control.
- D. The lien of the MORTGAGE is hereby modified as security for the payment of the principal sum evidenced by the NC TE and amended by this MODIFICATION AGREEMENT.
- E. This agreement shall be governed by and construed under the laws of the State of Illinois.

This instrument is executed by Mid Town Eank and Trust Company of Chicago not personally but solely as trustee, as aforesaid. All the covenants and conditions to be performed hereunder by Mid Town Bank and Trust Company of Chicago are undertaken by it solely as Trustee, as aforesaid and not individually, and no personal liability shall be asserted or be enforceable against Mid Town Bank and Trust Company of Chicago by reason of any of the covenants, statements, representations or wa randes contained in this instrument.
