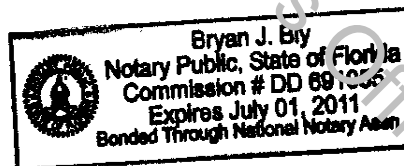

COMMITMENT - LEGAL DESCRIPTION

That part of Block 7 in Cleaversville, being a Subdivision of the North part of Fractional Section 2 Township 38 North, Range 14, East of the Third Principal Meridian, and part of the South Fractional Section 35 Township 39, Range 14, East of the Third Principal Meridian, described as follow: Commencing at a point in the Easterly line of Block 7 in Cleaversville, 50 feet Northerly from the Southeast corner thereof and running thence Northwestely on the Easterly line of said Block 3 feet; thence southwesterly on a line parallel with the Southerly line of said Block 180 feet to an alley, thence running Southeasterly on a line parallel to the Easterly line of said Block 31 feet thence Northeasterly on a line parellel to the Southerly line of said Block 180 to the place of the begining, in Cook County Illinois.
