Permanent Tax No: 32-28-112-020-0000, 32-28-112-021-0000

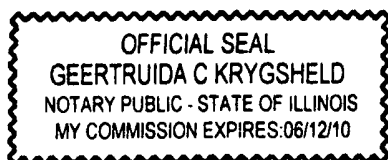
