## MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED OCTOBER 22, 1999, BETWEEN Vaso Preradovic and Kristi Sell-Preradovic (referred to below as "Grantor"), whose address is 2351 W. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
