IT IS FURTHER UNDERSTOOD AND AGREED THAT:

- Obligations Relating to Property. Borrower shall (a) not use or suffer or permit use I. of the Property for any purpose other than that for which the same is now used; (b) not initiate or acquiesce in any zoning reclassification without Lender's written consent; (c) pay each item of indebtedness secured by this Mortgage when due according to the terms hereof or of the Note; and (d) pay all filing, registration, recording and search and information fees, and all expenses incident to the execution and acknowledgement of this Mortgage.
