1. On February 26, 2008 and thereafter, Owner owned the land located in Cook County, Illinois, commonly known as 1 South State Street, Chicago, Illinois, and legally described as follows:

- 3. General Contractor was Owner's General Contractor and /or agent for improvements to the land.
- 4. On or about February 26, 2008, General Contractor made a subcontract with claimant under which claimant agreed to furnish glass, glazing and aluminum for 1 South State Street. The original contract amount was \$147,500.00.
- 5. On or about September 29, 2008, claimant last furnished labor, material and services for which this lien is filed.
- 6. As of the date hereof there is due unpaid and owing to claimant after allowing all credits, the principal sum of \$58,671.00 which principal amount bears interest at the statutory rate of 10% per annum. Claimant claims a lien on the land, improvements and the money or other consideration due or to become due from Owner against the General Contractor and Owner in the amount of \$48,671.00, plus interest, pursuant to the Illingus Mechanics Lien Act, 770 ILCS 60/1 et seq.
