- 3. Subsequent to this initial agreement between Owner and Tenant, the Tenant agreed to assume Lien Claimant's contract with the Owner. The Tenant was knowingly permitted and authorized by the Owner to contract with Lien Claimant for this shoring and scaffolding labor, materials, fixtures and equipment for repairs to the building erected.
 - 3. At the special instance and request of the Tenant, as one authorized or knowingly
