This cause coming on to be heard pursuant to the Verified Petition for Entry of Consent Judgment presented by Schiller, DuCanto and Fleck LLP and Lloyd E. Davidson, the Court being fully advised in the premises,

IT IS HEREBY ORDERED:

1. A Consent Judgment is hereby entered in favor of Schiller, DuCanto and Fleck LLP and against the Respondent, Lloyd E. Davidson, in the amount of \$7,507.72 which represents attorneys' fees and costs incurred incident to Schiller, DuCanto and Fleck LLP's representation of Lloyd E. Davidson through July 6, 2007.




