By written credit agreement dated June 1, 1992, Subcontractor entered into an open credit agreement with Lien Claimant whereby Subcontractor ordered material from Lien Claimant for use on projects which Subcontractor contracted to provide labor and material. On or around October 3, 2008, Subcontractor contacted Lien Claimant and requested Lien Claimant supply sewer, water and drainage material and fixtures to Subcontractor to and for the benefit of the premises. Thereafter, Lien Claimant supplied sewer, water and drainage material and fixtures to Subcontractor for use and incorporation into the premises.
- 5. The total value of sewer, water and drainage material and fixtures supplied to Subcontractor for use and incorporation into the premises was \$9,857.32.
- 6. On October 23, 2008, Lien Claimant substantially completed delivery of materials and fixtures to the value of \$9,857.32.
- 7. On information and belief, the materials, supplies, fixtures and services for said work and in the improvement of the aforementioned premises performed and supplied by Lien Claimant was done with the knowledge and consent of the Owners of the beneficial interest in the above named Trusts holding record title to the premises.
- 8. Subcontractor is entitled to credits on account thereof as follows: \$0.00, leaving due, unpaid and owing to Lien Claimant, after allowing all credits, the sum of \$9,857.32 for which, with interest, Lien Claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owners under said contract between Contractor and Owners and to monies or other considerations due or to become due from Contractor under said contract between Subcontractor and Contractor.
