REGISTRATION OF ADMINISTRATIVE JUDGMENT

PLEASE TAKE NOTICE that the judgment creditor, City of Chicago: through its attorneys, Talan & Ktsanes, Special Corporation Counsel, has registered an administrative judgment with the Circuit Court of Cook County, Illinois, as follows:

On 10/22/2005 administrative money judgment was rendered in the City of Chicago-Department of Administrative Hearings ('DAH'), in favor of the plaintiff, City of Chicago, against the defendant(s) ROBERT BAROOD pursuant to Illinois law, 65 ILCS 5/1-2.1-7 and 5/12.1-8, the defendant(s) either: (a) failed to seek administrative review within thirty-five (35) days for the administrative judgment: or (b) sought administrative review and failed to overturn the administrative judgment: or (c) sought administrative review but failed to seek or obtain a stay of the administrative money judgment.
