**AN ORDINANCE AMENDING  
ORDINANCE NUMBER 99-054  
ANNEXING CERTAIN TERRITORY  
TO THE VILLAGE OF ARLINGTON HEIGHTS**

WHEREAS, on August 16, 1999, the President and Board of Trustees of the Village of Arlington Heights, approved Ordinance Number 99-054, annexing 616, 620, 627 and 631 Rolling Lane and 2400 and 2424 East Euclid Avenue, into the Village; and

WHEREAS, the legal description and property index numbers contained within Ordinance Number 99-054 accurately describe the property annexed into the Village but that the common addresses also contained within the ordinance are in error,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES AS FOLLOWS:

SECTION ONE: That the common addresses contained within Ordinance Number 99-054, be and are hereby replaced with 615, 616, 620, 627 and 631 Rolling Lane, which properties are legally described as follows:

Lots 1 through 6, in Kehe's Fairway acres, being a subdivision of part of the East 10 acres of the South 660.45 feet of the West 1/2 of the Northeast 1/4 of Section 28, Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois. Together with all of Rolling Lane, Adjoining Lots 1 through 6, in Kehe's Fairway Acres, all in Cook County, Illinois.

P.I.N. 03-28-200-010, -011, -013, -014, -016, -021, -022

SECTION TWO: That the remaining provisions in Ordinance Number 99-054, shall remain in full force and effect.

SECTION THREE: This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law and shall be recorded in the Office of the Recorder of Cook County.
