MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 5, 2009, is made and executed between Jesus People, U.S.A., Full Gospel Ministries, an Illinois Not-For-Profit Corporation, whose address is 931-939 W.
