- 2. Claimant made entered into a written contract on September 25, 2007 with Owner (the "Contract") under which Claimant agreed to provide construction management services in furtherance of the construction of an ink processing facility in exchange for payment by Owner to Claimant.
- 3. The basic services compensation under the Contract was \$332,400.00. During the course of Claimants performance of services, Owner requested that Claimant perform certain additional and extra services. The value of such additional and extra services was \$213,509.00.
 - 4. Claimant last performed work under the Contract on or about November 28, 2008.
- 5. As of November 14, 2008, the value of the services Claimant performed under the Contract was \$5.5,909.00, for which Claimant has received \$410,829.50.
- 6. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing all credits, the principal belance of One Hundred Thirty Five Thousand Seventy Nine and 50/100 Dollars (\$135,079.50). Claimant claims a mechanics lien pursuant to 770 ILCS 60/1 et seq., in the total amount of \$135,079.50 plus such interest as allowed by law, against the interest of the Owner and other parties described above in the Real Estate.
