

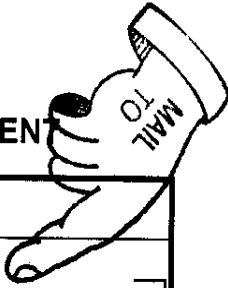

SCHEDULE A TO UCC FINANCING STATEMENT (1998-NL) FACILITY DESCRIPTION (THE "FACILITY")

The Facility more particularly described as Parcels 1 through 273 below, inclusive; *excepting therefrom and reserving unto* the CTA rights and properties as follows provided the same do not unreasonably and adversely affect in any material respect the ability of the Head Lessee to use and operate the Undivided Interest in the Facility in accordance with the Operative Documents (all such rights and properties excepted and reserved herein are hereinafter referred to as the "*Reserved Rights*"): (i) [intentionally omitted], (ii) of access over and through the Facility for maintenance purposes (including, without limitation, the right to transport railcars, workers and materials to and from various yards and maintenance shops located along or at any terminus of the Facility), (iii) of access over and through the Facility for emergency purposes, (iv) of access over and through the Facility to allow performance of its obligations and exercise of its rights by CTA under the Joint Operating Agreement and the Support Agreement, (v) all railroad yards, maintenance facilities and shops, (vi) subject to the Support Agreement, to lease, encumber and grant security interests or other rights in those portions of the Facility used in connection with other passenger train lines, and (vii) to use the Facility in connection with the current and future installation, operation and maintenance of electrical power transmission facilities and equipment, communication (including, without limitation, fiber optic transmission facilities) and data transfer equipment, signaling equipment, or switching equipment; all without regard to whether or not the same are used exclusively by the CTA or by third parties:

(Harlem Avenue east to point of connection to Lake Street)

A non-exclusive interest in and to CTA's interest in the railroad right-of-way of various widths arising under that certain Indenture made January 6, 1959, as amended from time to time, between the Union Pacific Railroad Company, as successor to the Chicago and Northwestern Railway Company, as lessor, and CTA, as lessee, a memorandum of which was recorded as Document Number _____ in the Office of the Recorder for Cook County, Illinois, together with all trackage, guideways, switches, electrical systems, signal systems, communications systems, revenue collection systems located on portions of Parcels 1(a) through 1(d), inclusive, described hereinbelow as depicted on *Schedule A1* attached hereto and made a part hereof, and all appurtenances, including, without limitation, the passenger platforms and stations over and along said real property.
