MEMORANDUM OF COLLATERAL ASSIGNMENT AND REASSIGNMENT OF LEASE AND RENTS


This Memorandum of Collateral Assignment and Reassignment of Lease and Rents is made February 26, 2009 by and among JT's Auto Body of Barrington, Inc. ("SBC"), and J & DT Enterprises, LLC ("Borrower") and SOMERCOR 504, INC., an Illinois corporation ("Lender").

WITNESSETH:


