AMENDMENT NO. 1 TO ASSIGNMENT OF LEASES AND RENTS – ELSTON AVENUE PROPERTIES, L.L.C.

Amendment No. 1 to Assignment of Deases and Rents (this "Amendment") dated as of January 11, 2009, made by ELSTON AVENUE PROPERTIE'S, L.L.C. ("Assignor") in favor of FIRST MIDWEST BANK ("Assignee"). This Amendment pertains to the recent estate described on Exhibit A attached hereto and made a part hereof.

PREAMPLE:

Assignor gave to Assignee that certain Assignment of Legges and Rents dated August 25, 2008, which was recorded on November 13, 2008, in the Office of the Cook County. Illinois Recorder of Deeds as Document No. 0831841159 (the "Assignment"). Assignor has requested Assignee to modify Assignee's existing financing of Assignor. Assignee has agreed to do so, so long as, among other things, Assignor executes and delivers to Assignee this Amendment.

NOW, THEREFORE, in consideration of the premises which are incorporated herein by this reference and constitute an integral part hereof and the execution and delivery of this Amendment, Assignor agrees as follows:

- 1. Section 1.01 of the Assignment is deleted in its entirety and replaced by the following:
- "1.01 Note. Pursuant to that certain Loan and Security Agreement dated as of August 25, 2008, as amended from time to time, including, without limitation, as of the date of Amendment N. 1 to this Assignment entered into by and between Assignee and Assignor (said Loan and Security Agreement, as amended, and as may be further amended or restated from time to time, shall be hereinafter referred to as the "Loan Agreement"), that certain Construction Note (said Construction Note, as may from time to time be amended, modified, substituted, restated, renewed and/or extended, shall hereinafter be referred to as the "Note") in the principal amount of \$20,875,000.00 payable, along with interest, and maturing as specified in the Note, has been or is being contemporaneously executed and delivered by Assignor to Assignee. The Note contemplates a variable rate of interest."
- 2. All references to the "Assignment" in the Assignment shall mean the "Assignment" as amended by this Amendment and as may be further amended and/or restated from time to time.




