MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 15, 2009, is made and executed between Oketo Pointe, LLC, an Illinois Limited Liability Company, whose address is 416 W. If the index increases, the payments tied to the index, and therefore the total amount secured hereunder, will increase. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
