AGREEMENT TO AMEND AND RESTATE PARTICIPATION AGREEMENT, NOTE AND MORTGAGE

(Single-Family Rehabilitation Program)

This Agreement is entered into effective June 1st, 1999 by and between the West Suburban Neighborhood Preserva ion Agency, an Illinois intergovernmental agency (the "Lender") and Roberta Darnell Burtor, divorced and not yet remarried (the "Mortgagors").

WHEREAS, the West Suburban Normborhood Preservation Agency and the Mortgagors executed a Single-Family Rehabilitation Program Cowners Participation Agreement the ("Agreement") dated January 6, 1999 to provide the Mortgagors with a loan for the purpose of providing the Mortgagors with funds sufficient to rehabilitate their home.

WHEREAS, the Mortgagors have executed and delivered to the West Suburban Neighborhood Preservation Agency a Mortgage Note dated January 6, 1999 wherein the Mortgagors promise to pay to the order of the West Suburbar Neighborhood Preservation Agency the principal sum of Twenty-Thousand Eight-Hundred Twenty-Seven and 00/100 Dollars (\$20,827.00) (the "Note") in repayment of a loan to the Notegagor from the owners in like amount, together with interest thereon (the "Loan"), in installments as set forth therein.

WHEREAS, the Mortgagors also executed and delivered to the Agency a Mortgage (the "Mortgage") dated January 6, 1999, and recorded on March 19, 1999 as decurrent #99270054, to secure the indebtedness set out in the Note which Mortgage conveyed an interest in the property as described herein:

1. **RECITALS**

That the foregoing recitals are incorporated herein and made a part hereof by reference.

2. AMOUNT OF LOAN, NOTE AND MORTGAGE

That the West Suburban Neighborhood Preservation Agency and the Mortgagors hereby agree that the principal amount of the Agreement, Note and Mortgage shall be amended and restated to be Thirty Thousand Six Hundred Fifty-Two and no/100 Ocllars (\$30,652.00) and shall no longer be the amount of Twenty-Thousand Light-Hundred Twenty-Seven and 00/100 and 00/100 Dollars (\$20,827.00).

3. REMAINING TERMS, CONDITIONS AND COVENANTS

That the Owners and the Mortgagor agree that all other terms, conditions and covenants of the Agreement. Note and Mortgage shall remain in full force and effect for the term of the Agreement, Note and Mortgage as set out therein.
