This document is recorded for the purpose of amending the By-Laws of the Amended and Restated Declaration of Condominium Ownership (hereafter the "By-Laws") for the 1500 Sheridan Road Homeowners Condominium Association, (hereafter the "Association"), which Declaration was recorded on October 21, 2003, as Document Number 0329439191, in the Office of the Recorder of Deeds of Cock County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A" which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Article II, Section (b) of the By-Laws which states that the voting members having at least two-thirds (2/3) of the total votes may from time to time increase or decrease the number of persons on the Board at any annual or special meeting, provided that such number shall not be less than three (3) and that the terms of at least one-third (1/3) of the persons on the Board shall expire annually.

WHEREAS, by the Amended and Restated Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the contained therein; and

WHEREAS, the Board of Directors and the Owners desire to amend the By-Laws of the Amended and Restated Declaration in order to provide for the orderly operation of the Property; and

NOW, THEREFORE, the By-Laws of the Amended and Restated Declaration of Condominium Ownership for the 1500 Sheridan Road Homeowners Condominium Association is hereby amended in accordance with the text which follows (deletions are struck out, additions are underlined):

1. Article II, Section 1 of the By-Laws entitled "Number and Qualification" shall be amended as follows:

Section 1. NUMBER AND QUALIFICATION. The direction and administration of the Property shall be vested in a Board of Directors (referred to in said Declaration and in the Condominium Property Act of the State of Illinois as the "board of managers", but referred to as the "board of directors" in the General Not for Profit Corporation Act of the State of Illinois and sometimes referred to herein as the "Board") consisting of nine (9) seven (7) persons who shall be elected in the manner herein provided. Each member of the Board shall be one of the Unit Owners; provided, however, that in the event a Unit Owner is a corporation, partnership, trust, or other legal entity other than a natural person or persons, then any office or director of such corporation, partner of such partnership, beneficiary of such trust, person designated by such trustee, or manager of such other legal entity, shall be eligible to serve as a member of the Board.

- 2. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 3. Except to the extent expressly sel forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
