THIS INDENTURE WITNESSETH, That the Grantor, FLORENCE C. LINDEMAN, a Widow and in consideration of ~~Ten--(\$10.00)--Dollars~~, and other good and valuable considerations in hand paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an Illinois Banking Corporation of the United

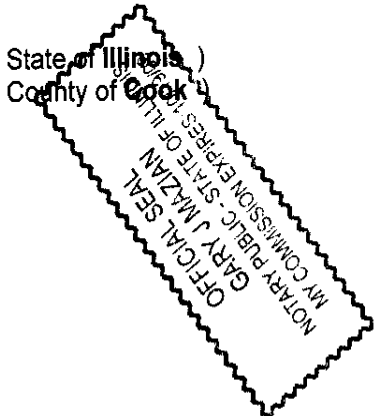

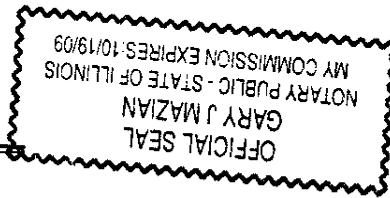

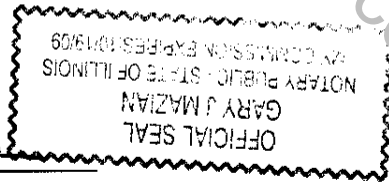
