SECOND AMENDMENT TO MORTGAGE, SECURITY AGREEMENT AND FIXTURE FILING

WHEREAS, an Operation and Reciprocal Easement Agreement made by Mortgagor dated December 17, 2008 was recorded December 18, 2008 as document number 0835339015, and the R&D 659 Declaration of Condominium dated December 17, 2008 was recorded December 18, 2008 as document number 0835345105;

WHEREAS, in connection with that certain Third Amendment to Acquisition and Construction Loan Agreement and Other Loan Documents between Mortgagor and Mortgagee (the "Loan Agreement Amendment") and that certain First Amendment to Assignment of Leases, Rents and Profits, each dated as of the date hereof, executed concurrently with the execution of this Second Amendment to Mortgage, Security Agreement and Fixture Filing, Mortgagor has executed and delivered to Mortgagee that certain Payment Guaranty and Indemnification Agreement dated as of the date hereof (the "Payment Guaranty");

WHEREAS. Mortgagor and Mortgagee desire to secure by the conveyance of Mortgagor's interest, in the Mortgaged Property, the full and punctual payment of the Obligations (as defined in the Payment Guaranty), and the full and punctual performance and observance by Mortgagor of all of the covenants, agreements, terms, conditions and provisions to be performed or observed under the Payment Guaranty;

WHEREAS, Mortgagor agrees that the Mortgage shall secure the obligations of Mortgagor under the Payment Guaranty, and

WHEREAS, Mortgagor and Mortgage a desire to amend the Mortgage to reflect the foregoing.

NOW, THEREFORE, in order to induce the Mortgagee to enter into the Loan Agreement Amendment and in order to secure the prompt payment and performance of Mortgagor's obligations under the Payment Guaranty and in consideration of the mutual agreements herein contained and for and in consideration of One Dollar (\$1.00) in hand paid, receipt whereof is hereby acknowledged, the parties hereby amend the Mortgage as follows:

AGREEMENTS

- 1. Obligations. The Obligations, as defined in the Payment Guaranty, and all other amounts outstanding under the Payment Guaranty shall constitute and be added to tre Obligations, as defined and used in, and secured by, the Mortgage.
- 2. Except as expressly amended hereby, the Mortgage shall remain in full force and effect. The Mortgage and all rights and powers created thereby and thereunder or under such other Loan Documents are in all respects ratified and confirmed. From and after the date hereof, the Mortgage shall be deemed to be amended and modified as herein provided, but, except as so amended and modified, the Mortgage shall continue in full force and effect and the Mortgage and the applicable portions of this Amendment shall be read, taken and construed as one and the same instrument. On and after the date hereof, the term (a) the "Mortgage" as used in the Note, the Loan Agreement and all other Loan Documents shall mean the Mortgage as amended by this Amendment; and (b) "Loan Document" as used in the Mortgage or any other Loan Document

shall include the Payment Guaranty and that certain Cash Collateral Pledge Agreement dated as of the date hereof, made by Mortgagor for the benefit of Mortgagee.

- 3. Nothing contained in this Amendment shall be deemed to release, modify, amend or waive the lien of the Mortgage, in whole or in part, in any manner whatsoever.
- 4. Reference is made to Section 10 of the Loan Agreement, the terms, conditions and limitations thereof being incorporated herein by this reference.
